## Notice of Motion for 2009 AGM

### Introduction of Associate Membership Category

As a new section 5, following Section 4 "Honorary and Life Members" of the Domestic Regulations of the Northern Suburbs Training and Obedience Dog Club, it is proposed that the following be added.

### **5. Associate Membership**

5.1 An individual may join the club as an "Associate Member" if, either:

- the membership does not include a dog; or
- the membership includes one or more dogs, but the dog will not participate in training or club members' trials.

5.2 An Associate Membership is entitled to the same voting rights as other financial members

### **Fees**

It is proposed that the following fees are appended to Appendix 1 – Current Membership Fees

### **From 1<sup>st</sup> November to 30 June**

Associate Membership \$10.00

### **From 1<sup>st</sup> July**

Associate Membership \$5.00

### Taking Nominations of Office Bearers from the Floor

It is proposed that section 25.3, paragraph a) be amended to read:

***"Nominations for elections may be taken off the floor"***

It is also proposed that this amendment is effective immediately.
